

2020 USTA NAZ ADULT LEAGUE REGULATIONS

Version: November 13, 2019

The following regulations shall apply to all Northern Arizona (NAZ) League matches:

- USTA National League Regulations
- USTA Southwest Section League Regulations
- USTA NAZ League Regulations: Described in this Document
- USTA Friend at Court and the Code

These USTA NAZ League Regulations are approved and adopted by the USTA NAZ Board of Directors and, going forward, may be changed or amended as appropriate upon recommendations from the NAZ Advisory Council and/or NAZ Adult League Committee.

CAPTAIN'S RESPONSIBILITIES

1) It is the Captain's Responsibility:

- For knowing and following all current USTA League Regulations (as listed above). Once a team signs up, they are agreeing to abide by all the rules and regulations as well as any procedures and instructions discussed with the Captains.**
- To verify their contact information is up to date in TennisLink.
- To verify host facility availability and pay all associated court fees due (reimbursed by players).
- To secure a team number and instruct players to register in "Tennis Link".
- To verify all players are registered prior to any match play.
- Notify the NAZ League Coordinator of any dates in the season that may be in conflict for most of the team. League Coordinator will do their best to accommodate.
- To ensure team complies with the NAZ residency requirement.
- To make every effort to fill their teams with available players currently in the appropriate NTRP rating level players before adding players from the next lower level. Exceptions would be players playing on both teams at one time.

LEAGUE RESIDENCY REQUIREMENTS

- A team from Northern Arizona may not advance to championship play if their final roster contains less than Sixty-Five Percent (65%) "qualified players" whose primary residence is in the scope of the NAZ USTA district boundaries or own a home in the NAZ USTA district boundaries (in members name).
- If prior to playing any matches, a team is found to be out of compliance, the Captain may pick which player(s) to remove to come into compliance. If a team is not in compliance with the Sixty-Five Percent (65%) requirement (i.e. has an ineligible player on its roster), all matches played by that ineligible player will be scored as a default in determining final standings. Ineligible player shall be defined as the last out-of-area player to register on the roster (as determined by that player's registration date).
- For all advancing NAZ teams, the Residency Requirement shall be waived when a division of a league is unable to form for the lack of two teams (one team or none).
 - If the residency waiver is employed (league is formed with non-resident teams), the team captains will be required to accept eligible players from NAZ, under the residency requirement, to play on the non-resident teams within the appropriate NTRP level. The appropriate NTRP level shall be all in level players, i.e. 3.5 players for a 3.5 league, 4.0 players for a 4.0 league. In the case of combined leagues, i.e. for a 7.0 league, an eligible player shall be a 3.0, 3.5 or 4.0 player. Any exceptions will be decided by the NAZ League Coordinator.

LEAGUE COURTS

- There may not always be the appropriate number of courts at a match site to simultaneous play all courts in a match. Please consider this when scheduling courts and make sure you and the opposing Captain agree on playing order.
- Please make opposing Captain and team aware of closest bathroom facilities and whether water is available on site or not.
- If there is not an available date for a home match, the match may revert to a location that has available courts at the NAZ League Coordinator's discretion.

OFFICIAL PLAYING SURFACE

- 1) If playing on a surface other than hardcourt, please make sure the opposing Captain agrees to play on an alternative surface. (i.e.; grass courts at McPherson Park in Flagstaff)

NORTHERN ARIZONA LEAGUE SCHEDULING

- 1) In general, matches, will be scheduled as double-headers on Saturdays and/or Sundays to accommodate visiting team travel time. However, at the NAZ League Coordinator discretion, a single match may be scheduled to accommodate Northern Arizona weather, shortness of daylight, or other special circumstances.
- 2) Divisions in Northern Arizona will play a **round-robin** format. The winner of the round robin will advance to the next championship level.
- 3) A minimum of six (6) matches will be scheduled each season. This may be waived by the NAZ League Coordinator.
- 4) An attempt will be made to allow each team equal hosting opportunities. The NAZ League Coordinator reserves the right to schedule matches that will not allow equal hosting opportunities due to the lack of available courts, weather, and other scheduling challenges.
- 5) If known in advance that your team will default a court, please notify the opposing Captain at least two (2) days prior and follow the default table below. Please be courteous so that players don't end up traveling unnecessarily.
- 6) In the event of a last-minute default (sickness, car problems, special circumstances, etc.), please notify the opposing Captain to attempt a reschedule prior to just calling for a default.
- 7) In the case of a potential total team default, contact the NAZ League Coordinator in advance to see if another solution is possible.

MATCH FORMAT

- 1) All matches will consist of the best of 3 sets, with a (10 point) MATCH TIE-BREAK played in lieu of a third set.
- 2) A (7 point) SET TIE-BREAK will determine a set at 6-games-all.
- 3) The COMAN TIE-BREAK PROCEDURE will be used in all tie-breaks.

RESCHEDULE OF MATCHES

- 1) Rescheduled Matches:
 - a. At the NAZ League Coordinator's discretion, requests to reschedule MUST be accommodated by the opposing team when there is a Team conflict due to a Sectional or National League Championship representing NAZ. Five (5) days advance notice to opposing Captain and League Coordinator is required, or the match MAY be played as scheduled.
 - b. Weather related matches must be completed before the last regularly scheduled match in that division unless approved by the NAZ League Coordinator. The League Coordinator must be advised of the reschedule date prior to the original match date when possible.
 - c. Matches may be rescheduled IF BOTH CAPTAINS AGREE upon a date/time which occurs prior to the last regularly scheduled match in that division AND both Captains send written consent (via email or text) along with the new date/time to the NAZ League Coordinator no later than five (5) days after the original match date. Exceptions will be at the discretion of the League Coordinator.

OFFICIAL MATCH TIME AND DEFAULTS

- 1) It is recommended that both teams arrive at the match site at 30 minutes prior to scheduled match time. Any changes to start time listed in TennisLink, shall be agreed upon in advance of the match and in writing (email or text) by both Captains.
- 2) The second match of a double header shall start as soon, as can be reasonably expected, after the first match has been completed.
- 3) Team Captains or their representative shall exchange their team line-ups simultaneously prior to the beginning of the team match. USTA Reg. 2.01C(5). Line-ups will be exchanged in time to start the match at

the agreed upon time. Both Captains should have their line-ups prepared prior to the exchange. The same shall apply to the second match of a double header.

- 4) No substitutions may be made in a match after the line-ups have been exchanged, unless there is an illness or injury of a player prior to the start of the match. USTA Reg. 2.01C(5)
- 5) The USTA Point Penalty System shall be used. Default time is 15 minutes after the scheduled match time. Time penalties will be enforced: 5 minutes or less, 1 game, and the toss; 5:01 -10 minutes, 2 games and the toss; 10:01-15 minutes, 3 games and the toss; after 15 minutes, default.
- 6) The order of individual defaults in NAZ local leagues is the same as the USTA National League Regulation 2.03K: Team Defaults. A team must have a minimum number of eligible players available for play in each team match in accordance with the following table or the entire match must be defaulted. The maximum number of positions that may be defaulted without defaulting the entire match is noted. When defaults are necessary, the defaults shall be determined by the defaulting Captain in accordance with the table below:

It is suggested that the line-ups be filled out placing any potential late players in the default positions, so that the other matches will not be penalized for delays described in rule 5 above.

- 7) No coaching is allowed **at any time** during a league match, including between sets, or between the second set and a match tie-break. USTA Reg. 2.01D

SCORE ENTRY

- 1) All match results should be entered in TennisLink by the home Captain and confirmed by opposing Captain within 48 hours after the match is played. Either team may enter scores. If the match is not confirmed, the initial entry will be considered valid and no appeals will be granted.
- 2) It is the Captain's responsibility to report any teams not entering their scores or entering incorrect players or scores to the league coordinator.
- 3) Both Captains (or designated proxies) should agree on scores at the conclusion of the match before leaving the facility. If there is a discrepancy, the players involved in the match in question should agree on the correct score. It is suggested that the visiting team Captain (proxy) sign the home team Captain's score card to show agreement on scores.

TEAM REGISTRATION/PLAYER PROFILE/ELIGIBILITY FOR LEAGUE PLAY

- 1) All players must be at least 18 years old and registered in TennisLink to play a league match.
- 2) No refunds will be given after registration is accepted in TennisLink. All players should be made aware by the team Captain that they should not register for a team if they are not sure they will be able to

play. Exceptions will be at the discretion of the League Coordinator where a credit may be issued towards the player's next league registration.

- 3) The recommended maximum number of players on a team will be 18.
- 4) Anyone who falsifies information on a self-rate player profile or anyone who knowingly condones falsification of information may be subject to a NTRP Grievance and subject to suspension from league play for no less than 364 days.

PLAYER CONDUCT

- 1) In all league matches played without officials, the USTA Official publication, THE CODE, shall be observed. Courtesy is expected.

LEAGUE CHAMPIONS

- 1) Within one week after the official end of the season, the Captain of winning team must notify the League Coordinator of their intention in regard to advancement to the next championship round. If unable to attend, the berth may be offered to the second-place team or made available as a wild-card.

CHAMPIONSHIP PLAY

SECTIONAL CHAMPIONSHIP PLAYER ELIGIBILITY: 2020 USTA REG. 2.03A(3)a & b

1. Players must have played on the same team at the same level and same age group in at least two local league matches and be otherwise eligible to advance to Sectional Championships.
2. Early Start League (ESL) players moved up at Year End (YE) to a higher level than their ESL level of play WILL NOT qualify to advance to Sectional Championship level play. Per National Regulations, this rule DOES NOT APPLY to the 2.5 LEVEL, with the exceptions of individual 2.5 player whose YE rating has reached the clearly above level or has been Disqualified.
3. A maximum of one default received during local league play shall count.
4. Retired matches shall count toward advancing for all players involved in the match.

NATIONAL CHAMPIONSHIP PLAYER ELIGIBILITY: 2020 USTA Reg. 2.03A(4)

1. Computer rated players must have played on the same team at the same level and same age group in at least **three matches** and be otherwise eligible to advance to National Championships. A maximum of one default received during local league or championship play (i.e. play-offs and sectionals) shall count.
2. Self-rated and Appealed Computer rated players must have played in **four matches** on the same team at the same level in the same age group **with no defaults** and be otherwise eligible to advance to National Championships.
3. Retired matches shall count toward advancing for all players involved in the match.
4. Move-up / Split-up Rule: All rostered members of a team who qualify to advance to a National Championship must adhere to the national regulation as described in the most current USTA League Regulations.
